**Apply / Analyze.** Pick-up every fix, ESU, ASU released from Oracle and apply it in the Birlasoft's E19.2 environment as they become available


**Feedback.** Send feedback to Oracle JD Edwards product strategy, if any issues or problems are encountered and get it fixed as necessary
