

The Board of Directors of Birlasoft Limited ('the Company') issued the postal ballot notice dated February 14, 2023 (hereinafter referred as "Notice") and decided to provide to the members of the Company, facility to exercise their voting rights on the resolution as set out in the notice through Postal Ballot ("remote e-voting"); as required under the provisions of Section 108 and 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014.

I, Jayavant B. Bhavé, Proprietor, M/s J. B. 
The resolution has secured requisite majority of votes and has been passed as a Special Resolution.
